The Ethics Act prohibits elected public officials and full-time public employees, whether appointed or employed, from having a financial interest in any contract, purchase or sale over which their public position gives them direct authority or control, unless the total value of such contracts, purchases or sales does not exceed \$1,000 in a calendar year.
